#### New LL.M. in United States Law

In fall 2014 Wayne Law will welcome its first class of students in a new LL.M. in United States Law.

The U.S. Law LL.M. is designed for students with a first law degree from outside the United States. The 24-credit program immerses students in both the fundamentals of the American legal system and allows than 600 schools). CUPL will them to take classes in specialized areas of interest, such as corporate finance, intellectual property and international law. The degree provides the

education qualification for graduates to sit for the New York and California bar exams.

The foundation of the program is a cooperative agreement between Wayne Law and the China University of Political Science and Law, ranked as the number two law school in China (out of more send students to the new program each year and Wayne Law faculty will teach and lecture at the CUPL campus in Beijing. Studies Paul Dubinsky visited six other Chinese law schools in December to promote the new program.

The book will be published by Cambridge University Press in early 2015.

Professor Julia Qin, an expert in international trade and China's role in the World Trade Organization, has been invited to teach one semester each year at Tsinghua Law School in Beijing. Tsinghua is widely recognized as one of the top law schools in China. This is an exceptional honor for Julia and for Wayne Law.

## Professor Brad Roth's book earns high praise

Professor Brad Roth's book, Sovereign Equality and Moral Disagreement, published by Oxford University Press in late 2011, has continued to garner extraordinary praise from reviewers.

In the book, Brad provides readers with a working knowledge of the various applications of sovereign equality in international law and defends the principle of sovereign equality as a morally sound response to disagreements in the international realm.
